Kimitaka Matsuzato is a professor of political science at the Slavic Research Center, Hokkaido University. His recent focus has been placed on religions, unrecognized states, and transnationalism in the Black Sea Rim, the results of which can be seen in his article, "Inter-Orthodox Relations and Transborder Nationalities in and around Unrecognised Abkhazia and Transnistria," *Religion, State and Society* 37: 3 (2009), pp. 239 – 262. In 2007, he published a collection entitled *Imperiology: From Empirical Knowledge to Discussing the Russian Empire*. Akihito Kudo is a researcher at the Graduate School of Human Sciences at Osaka University. His research interests include modern Algerian and French colonial history. Currently he is engaged in a transdisciplinary project on conflict studies, where he focuses on migration and urban networks in the Mediterranean.

Toshihiro Higuchi is a PhD candidate at the History Department of Georgetown University. Trained as an environmental historian, Higuchi has published several works on the Cold War politics of radioactive fallout and environmental radiation safety standards. Recently he has started a new project, surveying the material and ideological relationships between nature and nation-(re)building in Japan throughout World War II. Kazuhiko Yago is a Docteur en Histoire (Ph.D.) of Université Paris X, and professor of economic history, Tokyo Metropolitan University. Specialised in financial and banking history, Yago has published several academic works on various subjects such as the French popular savings and public finances, the Bank for International Settlements and Russian economic history. Yago has been studying the archives of the Russian international banks and recently focusing his interest on imperiology studies.

Kiyohiko Sugiyama is associate professor of Oriental History at Komazawa University in Tokyo. He specialises in Qing Imperial History, especially the Manchus and the Eight Banner System. He authored "The Ch'ing Empire as a Manchu Khanate: The Structure of Rule under the Eight Banners," *Acta Asiatica* 88 (2005), and jointly edited *Shincho towa nani ka* [What Was the Qing Dynasty?], *Kan: History, Environment, Civilization* 16 (Tokyo, 2009).

Toyomi Asano is a professor of the School of International Liberal Studies of Chukyo University in Nagoya. He obtained his PhD at the Department of Advanced Social and International Studies at Tokyo

University. He is interested in the historical origins, development, and deconstruction of the Japanese Empire. In order to analyse these hotly debated issues, he adopts a unique methodology that derives from both legal history and international studies. He has published a book, *Teikoku Nihon no shokuminchi hosei* [The Colonial Legal System of the Japanese Empire] (Nagoya: Nagoya University Press, 2008), and edited several books, *Nanyo Gunto to teikoku kokusai chitsujo* [Micronesia under Japanese Rule from the Perspective of Both Imperial and International Order] (Tokyo: Jigaku-sha, 2007) and *Shokuminchi teikoku Nihon no hoteki tenkai*, [Legal Development of the Japanese Colonial Empire] (Tokyo: Shinzan-sha, 2004). In English, he has published "A Missing Link of the Institute of Pacific Relations in Japan: Japanese Anthropologists before and during WWII," *The Journal of Shibusawa Studies* 13 (2000), pp. 45-63 and "Abolishing Extraterritoriality and Legislating Nationality law in Manchukuo," *Bochumer Jahrbuch zur Ostasienforschung* 22 (1998), pp. 169-177. His articles are translated in Korea and his book on Taiwan history was published in Taiwan.
