Call for Papers

for the 2nd East Asian Conference of Slavic-Eurasian Studies 2010

The Chinese Association for East European, Russian, and Central Asian Studies (CAEERCAS), the Japanese Council for Russian and East European Studies (JCREEC), and the Korean Association of Slavic Studies (KASS), with delight, announce that the Second East Asian Conference of Slavic-Eurasian Studies on "Russia and Eurasia in the Remaking World Order" will be held in Seoul, Korea, on 4-5 March 2010.

Accordingly, seeking to organize vehement scholarly discussion, the KASS, organizing Association of the 2010 Convention, invites members of above mentioned Associations, and of course, other interested scholars to submit their proposals for panels and papers.

Guidelines for Proposals

General

- 1. All proposals of panels/papers have to be scholarly in nature, and have to be approved by the Organizing Committee of the 2010 Convention, consisted of the three participating Associations, i.e. the CAEERCAS, the JCREEC, and the KASS. Approved proposals will only be included in the programme of the 2010 Convention.
- 2. The official languages of the 2010 Convention are English and Russian. Interpreting service will not be available except for the open and closing ceremonies.
- 3. However, the language of the administration is English. All the correspondence, proposals, and abstracts have to be in English.
- 4. Panels/papers will be categorized into two, i.e. Social Science and Humanities & Arts inclusive of Linguistics.
- 5. The allocated time for a panel will normally be 2 hours in maximum, and 20 minutes for a presentation of paper.
- 6. Paper-givers are expected to submit their full paper including abstracts in due course.

Proposals for Panels:

- 1. Should identify the category of the panel, e.g. Social Science, Humanities & Art, or Linguistics.
- 2. Should normally be consisted of a chair-person, up to three paper-givers, and at least one discussant.
- Should be represented by one of panelist as an organizer of the panel who is expected to conduct all the
 necessary communications between the panelists and the Organizing Committee of the 2010 Convention, except
 personalized needs of participants such as hotel reservation etc.
- 4. Must be international in their composition. Panels comprised of participants from a single country will not normally be accepted.
- 5. Should include the title of the panel; name, rank/position, and academic affiliation of the panelists (i.e. a chair-person, paper-givers, a discussant), the titles of papers, though provisional they may be at this stage of proposal, and contact details of all the panel participants (postal addresses of affiliated institutions including zip code, phone & fax numbers in full with national code, local code, and extension if any, and email addresses).
- 6. Should include 300-400 word abstracts of the panel, and papers respectively.
- 7. Have to be submitted only after the panel organizer's obtaining the consent of all the panel participants.
- 8. Have to be in English only.

Proposals for Individual Papers:

- 1. Should identify the category of the panel, e.g. Social Science, Humanities & Art, or Linguistics.
- Should include the title of the panel; name, rank/position, and academic affiliation, the title of presentation
 though provisional they may be at this stage of proposal, and contact details (postal address of affiliated
 institution including zip code, phone & Fax numbers in full with national code, local code, and extension if any,
 and email address).
- 3. Should include a 300-400 word abstract of the paper.
- 4. Have to be in English only.

Procedures for Proposals

General

- Proposals have to be submitted electronically, and should be directed to: eacses2010@gmail.com. Only electronically submitted proposals will be considered.
- The deadline for proposals for panels and papers is 15 July 2009. Please note that the Organizing Committee strongly recommend earliest submission of proposals as the accommodation will be allocated on a 'first come, first served' basis.
- 3. All the proposals have to be in English.
- 4. The Organizing Committee of the 2010 Convention, consisted of the three participating Associations, i.e. the CAEERCAS, the JCREEC, and the KASS, will finalize the programme in July 2009.
- 5. Once a proposal for a panel/paper has been accepted, a full paper will have to be uploaded on the Convention Homepage before the deadline, which will soon be notified.
- 6. Deadline for final Changes of proposal will be announced after drafting the provisional programme of the Convention in a due course.

Format of the 2010 Convention

General

- 2 Special Panels of the topics of Social Science and Humanities & Arts will be co-organized by the three party of the Conventions, i.e. the CAEERCAS, the JCREEC, and the KASS.
- 2. 15 panels by KASS, 10 by CAREECAS, and 10 by JCREES will be initiated and organized.
- 3. 2 roundtable panels will be organized by the Organizing Committee of the 2010 Convention on the topics of Social Science and Humanities & Art.
