PETER WALDRON is Professor of Modern History at the University of East Anglia, UK. He was a foreign fellow at the SRC in 2018. His research interests focus on the political, social and cultural history of early twentieth century Russia. His books include *Radical Russia: Art, Culture and Revolution* (2017), *Russia of the Tsars* (2011), *Governing Tsarist Russia* (2007), *Between Two Revolutions: Stolypin and the Politics of Renewal in Russia* (1998), and *The End of Imperial Russia*, 1855-1917 (1997). His current work focuses on Russia's experience during the First World War and he has edited three volumes in the *Russia's Great War and Revolution* series.

ARBAKHAN MAGOMEDOV is the Professor and Chair of the Public-Relations Department at Ulyanovsk State University. He was a foreign fellow at the SRC at Hokkaido University in 2000–2001, as well as a visiting professor at Shimane University (2003) and Kansai University (2019). His current research focuses on Russian Arctic Politics. His recent English-language and Japanese-language papers have been published in the journals *Demokratizatsiya: The Journal of Post-Soviet Politics, Anthropology and Archeology of Eurasia, The Journal of the Center for Integrated Area Studies,* and *The Journal of ROTOBO*. He is the author of the monograph *Russian Arctic Politics: Resources, Infrastructure, Indigenous People* (2000).

ALIM SABITOV, who passed away in May 2019, was a professor at Satbayev University in Almaty. His main research interests were space and time in art, contemporary art and cinema. He was a fellow at Oxford University's All Souls College (2005, 2007). BOJAN BELIĆ is the Principal Lecturer and Departmental Languages Coordinator in the Department of Slavic Languages and Literatures at the University of Washington (Seattle, USA). In 2016, he was a foreign fellow at the SRC, during which he expanded his research on minority Slavic languages. His other research interests include general Slavic syntax and Slavic language emancipation, as well as the teaching of Slavic languages. Together with Dieter Stern and Motoki Nomachi, he has co-edited the volume entitled *Linguistic Regionalism in Eastern Europe and Beyond: Minority, Regional, and Microliterary Languages* (2018). He currently serves as the vice president of the Southeast European Studies Association.

MIKHAIL SUSLOV is Assistant Professor of Russian Politics and History in the Department of Cross-Cultural and Regional Studies, University of Copenhagen. He was a foreign fellow at the SRC in 2017. He studies Russian history of ideas and ideologies, with a special focus on right-wing political and geopolitical imagination.
